WHEREAS, the Members of the Bids and Awards Committee, recommend Direct Contracting method of procurement for the Supply and Delivery of Various Biolog Supplies;

WHEREAS, the Philippine Center for Postharvest Development and Mechanization (PHilMech) sent Request for Quotation to Diamed Enterprise and quoted PhP 24,287.25/box of FF Microplate or PhP 48,574.50 for 2 boxes; PhP 11,762.50/box of GEN III Microplate or PhP 117,625.00 for 10 boxes; PhP 14,936.50/box of YT Microplate or PhP 74,682.50 for 5 boxes; PhP 4,134.00/box of GEN III Inoculating Fluid-A or PhP 8,268.00 for 2 boxes; and PhP 4,041.25/pack of Long Swabs 7" or PHP 8,082.50 for 2 packs.

WHEREAS, upon evaluation or careful examination, validation and verification of quotation submitted by the exclusive Supplier, Diamed Enterprise, its bid has been found to be responsive;
