INVITATION TO BID Supply and Delivery of 5 Units Motor Vehicle

(PHilMech Goods 16-03-02)

- 1. The Philippine Center for Postharvest Development and Mechanization (PHilMech) through its Regular Fund intends to apply the sum of PhP 6,300,000.00 being the Approved Budget for the Contract (ABC) as indicated herein to payments under the contract for the Supply and Delivery of 5 Units Motor Vehicle. Bids received in excess of the ABC shall be automatically rejected for Bid opening.
- 2. The Philippine Center for Postharvest Development and Mechanization now invites Bids from eligible bidders for the following items:

NOTE: Supplier must have a Service Center available within Region III and at least five (5) years in business.

Delivery of the GOODS is required within **Thirty (30)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within three (3) years a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents.

- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- 4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 10,000.00**. The method of payment will be **in cash**. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- 6. The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference open to all interested parties on April 22, 2016, 10:00am at at Executive Lounge, PhilMech Main Office, CLSU Compound Science City of Muñoz, Nueva Ecija.
