The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- 6. The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference open to all interested parties on February 10, 2017, 1:00pm at Philmech Liaison Office, 3rd Floor ATI Bldg., Elliptical Road, Diliman, Quezon City.

Bids and eligibility requirements must be delivered to the address below on or before **February 27, 2017.** All Bids must be accompanied by a Bid security in the form and amount stated in the Bid Data Sheet or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
