- The Philippine Center for Postharvest Development and Mechanization (PHilMech) through its Regular Fund intends to apply 1. the sum of PhP 10,500,000.00 being the Approved Budget for the Contract (ABC) as indicated herein to payments under the contract for the Supply, Delivery and Installation of Various Laboratory Fixtures (CO2017). Bids received in excess of the ABC shall be automatically rejected for Bid opening.

- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 5,000.00. The method of payment will be in cash. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- 6. The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference open to all interested parties on June 23, 2017, 10:00am at PHilMech Liaison Office, 3rd Floor ATI Bldg., Elliptical Road, Diliman, Quezon City.
- 7. Bids and eligibility requirements must be delivered to the address below on or before July 7, 2017. All Bids must be accompanied by a Bid security in the form and amount stated in the Bid Data Sheet or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
- Bid opening shall be July 7, 2017, 10:00am at at PHilMech Liaison Office, 3rd Floor ATI Bldg., Elliptical Road, Diliman, 8. Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
