**PHilMech Bids and Awards Committee**

**Re: Supply and Delivery of Five (5) Boxes of Immuno Affinity Column  
and One (1) Box of Fumonitest Column**

WHEREAS, the Philippine Center for Postharvest Development and Mechanization (PHilMech) posted the Request for Quotation in the G-EPS Website, PHilMech website and conspicuous places at the premises for the Supply and Delivery of Five (5) Boxes of Immuno Affinity Column and One Box of Fumonitest Column continuously for 7 days;

WHEREAS, Section 50 of the Revised IRR of RA 9184 authorizes to resort to Direct Contracting "those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the Government";

WHEREAS, VICAM Immuno Affinity Column and Fumonitest Column are exclusively distributed in the Philippines by Bihis Maala Basics (BMBASICS), per certification issued by Mr. Jerry Ding, Sales Manager of Asia-Pacific VICAM, A Waters Business;

WHEREAS, the Members of the Bids and Awards Committee, recommend Direct Contracting method of procurement for the Supply and Delivery of Five (5) Boxes of Immuno Affinity Column and One Box of Fumonitest Column;

WHEREAS, the Philippine Center for Postharvest Development and Mechanization (PHilMech) sent Request for Quotation to Bihis Maala Basics and quoted PhP 36,000.00/box or PhP 180,000.00 for 5 boxes of Immuno Affinity Column and PhP 40,589.00 for One Box of Fumonitest Column or a total amount of PhP 220,589.00;

WHEREAS, upon evaluation or careful examination, validation and verification of quotation submitted by the exclusive Supplier, **Bihis Maala Basics**, its bid has been found to be **responsive**;


NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as follows:
