The Philippine Center for Postharvest Development and Mechanization (PHilMech) through its Regular Fund intends to apply the sum of PhP 41,900,000.00 being the Approved Budget for the Contract (ABC) as indicated herein to payments under the contract for the Supply, Delivery and Installation of Various Chromatography and Spectroscopy Equipment (CO2018). - 2. Bidders should have completed within three (3) years a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- 4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 15,000.00. The method of payment will be in cash. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference open to all interested parties on February 12, 2018 10:00am at PHilMech CLSU Compound Science City of Muñoz Nueva Ecija.
- Bids and eligibility requirements must be delivered to the address below on or before February 26, 2018. All Bids must be accompanied by a Bid security in the form and amount stated in the Bid Data Sheet or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
