- The Philippine Center for Postharvest Development and Mechanization now invites Bids from eligible bidders for the following items:
 Delivery of the GOODS is required within Ninety (90) calendar days from receipt of the Notice to Proceed. Bidders should have completed within three (3) years a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- Interested Bidders may obtain further information from the Philippine Center for Postharvest Development and Mechanization and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 1,000.00**. The method of payment will be **in cash**. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
- 6. The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference open to all interested parties on December 14, 2018, 11:00am at PHilMech Liason Office, 3rd Floor ATI Bldg. Elliptical Road Diliman, Quezon City.
- 7. Bids and eligibility requirements must be delivered to the address below on or before January 11, 2019 All Bids must be accompanied by a Bid security in the form and amount stated in the Bid Data Sheet or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
- Bid opening shall be on January 11, 2018, 11:00am at PHilMech Liason Office, 3rd Floor ATI Bldg. Elliptical Road Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
