1. The Philippine Center for Postharvest Development and Mechanization now invites Bids from eligible bidders for the following items:
Delivery of the GOODS is required within **Twenty (30)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within three (3) years a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 1,000.00**. The method of payment will be **in cash**. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
6. The **Philippine Center for Postharvest Development and Mechanization** will hold a Pre-Bid Conference open to all interested parties on **January 9, 2019; 1:30pm** at **PHilMech Main Office, CLSU Science City of Muñoz Nueva Ecija**
7. Bids and eligibility requirements must be delivered to the address below on or before **January 23, 2019**. All Bids must be accompanied by a Bid security in the form and amount stated in the Bid Data Sheet or an equivalent amount in a freely convertible currency. Late Bids shall not be accepted.
8. Bid opening shall be on **January 23, 2019 ;1:30pm** at at **PHilMech Main Office, Science City of Muñoz Nueva Ecija**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
