



INVITATION TO BID

Rebidding for the Supply of labor and Materials for the Construction of Agricultural and Fisheries Mechanization and Engineering Resource Network Center building
(PHilMech Goods 19-04-15)

1. The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **Regular Fund** intends to apply the sum of **Php 34,185,516.12** being the Approved Budget for the Contract (ABC) as indicated herein to payments under the contract for the **Rebidding for the Supply of Labor and Materials for the Construction and Agricultural and Fisheries Mechanization and Engineering Resource Network Center Building (CO2019)**. Bids received in excess of the ABC shall be automatically rejected during Bid opening.
2. The Philippine Center for Postharvest Development and Mechanization now invites Bids from eligible bidders for **REBIDDING FOR THE SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF AGRICULTURAL AND FISHERIES MECHANIZATION AND ENGINEERING RESOURCE NETWORK CENTER BUILDING (CO2019)**. Completion of Works is required within **Three Hundred (300)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within three (3) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least 75% interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders on **May 15-22 2019** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 25,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Procurement System (Philgeps) and the website of the procuring entity provided that the bidders shall pay the non refundable fee for the bidding Documents not later than submission of their Bids.

6. The **Philippine Center for Postharvest Development and Mechanization** will hold a Pre-Bid Conference on **May 22, 2019, 10:00am** at **Executive Lounge, PHilMech Main Office, CLSU Compound Science City of Muñoz Nueva Ecija**, which shall be open to prospective bidders.
7. Bids must be delivered to the address below on or before **10:00am of June 5, 2019**. All Bids must be accompanied by a Bid security in any of the acceptable forms and in the amount stated in ITB Clause 12.

Bid opening shall be on **June 5, 2019; 10:00am** at the **Executive Lounge, PHilMech Main Office, CLSU Compound Science City of Muñoz Nueva Ecija**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late Bids shall not be accepted.

8. The **Philippine Center for Postharvest Development and Mechanization** reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
