SUPPLY DELIVERY AND TESTING OF RICE PRECISION SEEDERS

1. The Philippine Center for Postharvest Development and Mechanization (PHilMech) through its CY 2019 Rice Competitive Enhancement Fund (RCEF) intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the Supply Delivery and Testing of Rice Precision Seeders. Bids received in excess of the ABC of each Lot shall be automatically rejected during Bid opening.

- 2. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **Supply Delivery and Testing of Rice Precision Seeders**. Delivery of the GOODS is required within **Ninety (90)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183

- 4. Interested Bidders may obtain further information from the Philippine Center for Postharvest Development and Mechanization and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 23, 2019 to November 15, 2019 from the address below upon payment of the applicable fee for the Bidding Documents as stated above or PhP40,000.00 for all lots
