



INVITATION TO BID

Supply, Delivery and Testing of Rice Reapers (PHilMech-RCEF-19-10-08)

1. The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **CY 2019 Rice Competitive Enhancement Fund (RCEF)** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **Supply, Delivery and Testing of Rice Reapers**. Bids received in excess of the ABC of each Lot shall be automatically rejected during Bid opening.

2. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **Supply, Delivery and Testing of Rice Reapers**. Delivery of the GOODS is required within **Ninety (90)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183

4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 24-November 15, 2019** from the address below upon payment of the applicable fee for the Bidding Documents as stated above for all lots pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Procurement System (PhilGEPS) and the website of the Procuring Entity provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their Bids.
