- 2. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the Supply, Delivery and Testing of Mobile Rice Mills (PHilMech RCEF-20-06-08). Delivery of the GOODS is required within Ninety (90) calendar days from receipt of the Notice to Proceed. Bidders should have completed within Ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on July 2-August 4, 2020 from the address below upon payment of the applicable fee for the Bidding Documents as stated above or PhP50,000.00 for all lots pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Procurement System (PhilGEPS) and the website of the Procuring Entity provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their Bids.
