- 2. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the Supply, Delivery and Testing of Walking-Type Agricultural Tractors. Delivery of the GOODS is required within One Hundred Twenty (120) calendar days from receipt of the Notice to Proceed. Bidders should have completed within Ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested Bidders may obtain further information from the Philippine Center for Postharvest Development and Mechanization and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 26-October 20, 2020 from the address below upon payment of the applicable fee for the Bidding Documents as stated above or PhP 50,000.00 for all lots pursuant to the latest Guidelines issued by the GPPB.

- 6. The Philippine Center for Postharvest Development and Mechanization will hold a Pre-Bid Conference on October 6, 2020; 1:30pm at the PHilMech Main Office, Science City of Muñoz, Nueva Ecija, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before October 20, 2020. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
