The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **Supply, Delivery and Testing of Various Axial-Flow Threshers (PHilMech RCEF-20-09-17)**. Delivery of the GOODS is required within **One Hundred Twenty (120)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within Ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
