The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2019 & 2020 Rice Competitive Enhancement Fund (RCEF)** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **REBIDDING FOR THE SUPPLY, DELIVERY AND TESTING OF WALKING-TYPE AGRICULTURAL TRACTORS**. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **REBIDDING FOR THE SUPPLY, DELIVERY AND TESTING OF WALKING-TYPE AGRICULTURAL TRACTORS**. Delivery of the GOODS is required within **One Hundred Twenty (120)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183
4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **December 3 to December 28, 2020** from the address below upon payment of the applicable fee for the Bidding Documents as stated above or **PhP. 25,000.00** for all lots.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 28, 2020; 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity
