- 2. The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the REBIDDING FOR THE SUPPLY, DELIVERY AND TESTING OF VARIOUS AXIAL-FLOW THRESHERS. Delivery of the GOODS is required within One Hundred Twenty (120) calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183
