The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2019 & FY 2020 Rice Competitive Enhancement Fund (RCEF)** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **Supply, Delivery, Installation, Testing and Commissioning of Various Grain Dryers**. Bids received in excess of the ABC of each Lot shall be automatically rejected during Bid opening.

The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **Supply, Delivery, Installation, Testing and Commissioning of Various Grain Dryers**. Delivery of the GOODS is required within **One Hundred Twenty (120)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II - Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183
4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **December 4 to December 29, 2020** from the address below upon payment of the applicable fee for the Bidding Documents as stated above or **PhP 50,000.00** for all lots.
- Bidders may also opt to pay thru Landbank Account Fund Transfer. 

Bid opening shall be on **December 29, 2020; 1:30PM** at the **Auditorium, PHilMech Main Office, CLSU Compound, Science City of Muñoz, Nueva Ecija**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late Bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **December 29, 2020; 1:30PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity
10. In observance with the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases protocol on social distancing, **only one (1) designated / authorized representative per company** shall be allowed to participate and/or attend in the conduct of the bidding activities
