- 2. The PHilMech now invites bids from eligible bidders for the SUPPLY AND DELIVERY OF VARIOUS I.T EQUIPMENT (CO 2021). Delivery of the GOODS is required within Thirty (30) calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible Bidder is contained in the Bidding Documents particularly in Section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested Bidders may obtain further information from the PHilMech at the address given below during office hours (8:00 am to 5:00 pm) on weekdays only.
- A complete set of Bidding Documents may be acquired by interested Bidders on December 7-December 28, 2020 from
  the address below upon payment of a nonrefundable fee for the Bidding Documents as stated above or PhP 7,000.00 for
  all lots.
