The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2021 Rice Competitive Enhancement Fund (RCEF)** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF RICE MILL WITH IMPELLER HULLER**. The **Philippine Center for Postharvest Development and Mechanization** now invites bids from eligible bidders for the **SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF RICE MILL WITH IMPELLER HULLER**. Delivery of the GOODS is required within **One Hundred Twenty (120)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, a similar contract shall refer to any contract for the *Supply and Delivery of Agricultural Machineries*.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183
4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **May 12 to June 2, 2021** from the address given below upon payment of the applicable fee for the Bidding Documents as stated above or **PhP 20,000.00** for all lots.
