- The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2021 Regular Fund** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS I.T. - The PHilMech now invites bids from eligible bidders for the **REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS I.T. EQUIPMENT AND OTHER RELATED SUPPLIES FOR THE 3RD QUARTER OF 2021**. Delivery of the GOODS is required within **Thirty (30)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the Supply and Delivery of Various I.T and other Related Supplies.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- Interested Bidders may obtain further information from the **PHilMech** at the address given below during office hours (8:00 am to 5:00 pm) on weekdays only.
- A complete set of Bidding Documents may be acquired by interested Bidders on **June 23-July 14, 2021** from the address given below upon payment of a nonrefundable fee for the Bidding Documents as stated above or **PhP 3,500.00 for all lots**.


