



INVITATION TO BID

**REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS OFFICE SUPPLIES FOR THE 3RD QUARTER OF 2021 (PHILMECH-GOODS-21-06-11)**

1. The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2021 Regular Fund** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC), as indicated herein to payments under the contract for the **REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS OFFICE SUPPLIES FOR THE 3RD QUARTER OF 2021**. Bids received in excess of the ABC shall be automatically rejected during Bid opening.

2. The PHilMech now invites bids from eligible bidders for the **REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS OFFICE SUPPLIES FOR THE 3RD QUARTER OF 2021**. Delivery of the GOODS is required within **Thirty (30)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the Supply and Delivery of Various Office Supplies.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested Bidders may obtain further information from the **PHilMech** at the address given below during office hours (8:00 am to 5:00 pm) on weekdays only.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 23 – July 14, 2021** from the address given below upon payment of a nonrefundable fee for the Bidding Documents as stated above or **PhP 3,000.00 for all lots**.

Bidders may also opt to pay thru Landbank Account Fund Transfer.
