- The PHilMech now invites bids from eligible bidders for the **REBIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS I.T. EQUIPMENT AND OTHER RELATED SUPPLIES FOR THE 4<sup>TH</sup> QUARTER OF 2021**. Delivery of the GOODS is required within **Forty Five (45)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the Supply and Delivery of Various I.T. Equipment and Other Related Supplies.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
