INVITATION TO BID FOR

SUPPLY OF SECURITY SERVICES (FY 2022 Early Procurement) PHilMech Goods 21-11-16

Republic of the Philippines

- The Philippine Center for Postharvest Development and Mechanization (PHilMech) through its FY 2022 Regular Fund intends to apply the sum of PhP 6,435,792.00 being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Security Services. Bids received in excess of the ABC shall be automatically rejected during Bid opening.
- 2. The PHilMech now invites bids from eligible bidders for the **Supply of Security Services**. **Delivery of the good/service is required from January 1 to December 31, 2022**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids a contract similar to the Project. For this purpose, similar contract shall refer to the **Supply of Security Services**.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 19 December 13, 2021** from the address below upon payment of the applicable fee for the Bidding Documents in the amount of **PhP 6,000.00**.

Bidders may also opt to pay thru Landbank Account Fund Transfer.
