The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2021 Regular Fund** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC), as indicated herein to payments under the contract for the **REBIDDING FOR THE SUPPLY OF LABOR AND MATERIALS FOR THE FABRICATION, ON-SITE DELIVERY, INSTALLATION, AND TESTING OF 2 UNITS RESEARCH PROTOTYPE OF GREENHOUSE TYPE SOLAR DRYERS IN QUEZON**. Bids received in excess of the ABC shall be automatically rejected during Bid opening.

The Philippine Center for Postharvest Development and Mechanization now invites bids from eligible bidders for the **REBIDDING FOR THE SUPPLY OF LABOR AND MATERIALS FOR THE FABRICATION, ON-SITE DELIVERY, INSTALLATION, AND TESTING OF 2 UNITS RESEARCH PROTOTYPE OF GREENHOUSE TYPE SOLAR DRYERS IN QUEZON**. Delivery of the GOODS is required within **One Hundred Twenty (120)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, a similar contract shall refer to any contract for the *Supply, Delivery and Fabrication of Similar Agricultural Machineries/ Facilities*.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183


