- The PHilMech now invites bids from eligible bidders for the **SUPPLY AND DELIVERY OF THHN ELECTRICAL COPPER WIRE**. Delivery of the good/service is required within **Thirty (30) calendar days** upon receipt of the Notice to Proceed. Bidders should have completed, within **ten (10) years** from the date of submission and receipt of bids a contract similar to the Project. For this purpose, similar contract shall refer to the **Supply and Delivery of Electrical Wires**.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **June 30, 2022; 10:00AM** at the address given below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity
10. **Only one (1) designated / authorized representative per company** shall be **physically** allowed to participate and/or attend in the conduct of the bidding activities in consideration of the Inter-Agency Task Force (IATF) social distancing protocol on the management of emerging infectious diseases.
