The **Philippine Center for Postharvest Development and Mechanization (PHilMech)** through its **FY 2022** intends to apply the below-specified amounts, being the Approved Budget for the Contract (ABC) for each lot, as indicated herein to payments under the contract for the **SUPPLY AND DELIVERY OF VARIOUS INKS AND TONERS**, Bids received in excess of the ABC of each Lot shall be automatically rejected during Bid opening.

2. The PHilMech now invites bids from eligible bidders for the **SUPPLY AND DELIVERY OF VARIOUS INKS AND TONERS**. Delivery of the GOODS is required within **Thirty (30) calendar days** from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the **Supply and Delivery of Inks or Toners**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

7. Bids must be duly received by the BAC Secretariat through manual submission at the address indicated below on or before **10:00AM of July 25, 2022**. Late Bids shall not be accepted.

Participating bidders who submitted their bid proposals on time may also attend via video conferencing. A Personal Meeting ID shall be provided to the authorized representative through email.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **July 25, 2022; 10:00AM** at the address given below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Only one (1) designated / authorized representative per company shall be physically allowed to participate and/or attend in the conduct of the bidding activities in consideration of the Inter-Agency Task Force (IATF) social distancing protocol on the management of emerging infectious diseases
11. The **PHilMech** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA9184 and its IRR without thereby incurring any liability to the affected bidders or bidders.
