The **PHilMech** now invites bids from eligible bidders for the **SUPPLY AND DELIVERY OF VARIOUS ADVOCACY COLLATERALS.** Delivery of the GOODS is required within **Sixty (60)** calendar days from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, a similar contract shall refer to any contract for the **Supply and Delivery of Various Advocacy Collaterals or Any Promotional Materials.**
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183
