2. The PHilMech now invites bids from eligible bidders for the **SUPPLY, DELIVERY, INSTALLATION AND TESTING OF VARIOUS RICE MILLS**. Delivery of the GOODS is required within **One Hundred Eighty (180) calendar days for 1.5tph, and Two Hundred Fifty (250) calendar days for 2-3tph and 4-5tph Multi Stage Rice Mill** from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, a similar contract shall refer to any contract for the **Supply, Delivery, Installation and Testing of Rice Mills and Recirculating Grain Dryers**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested Bidders may obtain further information from the **PHilMech** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders during office hours from **October 3 to October 24, 2022** from the address below upon payment of the applicable fee for the Bidding Documents as specified for each lot above.
