- 2. The PHilMech now invites bids from eligible bidders for the **SUPPLY AND DELIVERY OF VARIOUS SOFTWARE AND I.T. EQUIPMENT**. Delivery of the GOODS is required within **Thirty** (30) Calendar Days for the softwares and One Hundred Twenty (120) calendar days for the hardwares from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the Supply and Delivery of CAD and Simulation Analysis Software for Lots No. 1A & 2A and Supply and Delivery of I.T. Equipment for the other Lots.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
