- 2. The PHilMech now invites bids from eligible bidders for the SUPPLY, DELIVERY, INSTALLATION AND TESTING OF VARIOUS SINGLE-PASS RICE MILLS. Delivery of the GOODS is required within One Hundred Twenty (120) calendar days for Mobile/Trailed Type and Ninety (90) calendar days for Stationary Single Pass Rice Mill from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, a similar contract shall refer to any contract for the Supply, Delivery, Installation and Testing of Rice Mills and Recirculating Grain Dryers.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the 2016 Revised Implementing Rules and Regulations (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of
