2. The PhilMech now invites bids from eligible bidders for the **SUPPLY AND DELIVERY OF VARIOUS SOFTWARE AND I.T. EQUIPMENT**. Delivery of the GOODS is required within **Thirty (30) Calendar Days for the software and One Hundred Twenty (120) calendar days for the hardware** from receipt of the Notice to Proceed. Bidders should have completed within ten (10) years from the date of submission and receipt of bids a contract similar to the project. For this purpose, similar contract shall refer to the **Supply and Delivery of CAD or Simulation Analysis Software for Lot No. 1 and Supply and Delivery of I.T. Equipment for Lot No. 2**.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino Citizens/sole proprietorships, cooperatives and partnerships and organizations with at least (60%) interest of Capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested Bidders may obtain further information from the **Philippine Center for Postharvest Development and Mechanization** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.

5. A complete set of Bidding Documents may be acquired by interested Bidders during office hours from **December 1 to December 20, 2022** from the address below upon payment of the applicable fee for the Bidding Documents as specified for each lot above.
