



THIS AGREEMENT made the 11 day of JULY 2023 between **PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHilMech)** of the Philippines (hereinafter called "the Entity") of the one part and **3R METAL CRAFT** of **40 Tandang Manang Street, Brgy. Parada, Valenzuela City, Metro Manila** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "**Supply, Delivery, Installation, Testing and Commissioning of 1 unit 1.5tph Multi Stage Rice Mill for Region VII, Lot 7**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eleven Million Fifty Thousand Pesos and 00/100 only (Php 11,050,000.00)** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


