**CONTRACT FOR THE SUPPLY AND DELIVERY OF 1,000 PCS RPS ADVOCACY BAG AND 1,000 PCS CES ADVOCACY BAG
LOT 3
(PHILMECH-GOODS-23-04-05-03)**

THIS AGREEMENT made the 12 JUL 2023 day of _____ 2023 between **PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHilMech)** of the Philippines (hereinafter called "the Entity") of the one part and **EFPIEL ENTERPRISES of 15th Avenue cor. Columbia St., Brgy. E Rodriguez, Quezon City** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "**Supply and Delivery of 1,000 pcs RPS Advocacy Bag and 1,000 pcs CES Advocacy Bag, Lot 3**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Hundred Eighty Six Thousand Pesos and 00/100 only (Php 286,000.00)** (hereinafter called "the Contract Price").

 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**



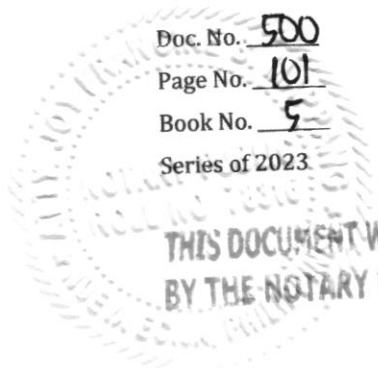
