


**CONTRACT FOR SUPPLY, DELIVERY AND TESTING OF 57 UNITS RICE COMBINE HARVESTERS
FOR REGIONS CAR & II
LOT 1
(PHILMECH-RCEF-23-08-18)**

THIS AGREEMENT made the 14th day of OCT 2023 between **PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHilMech)** of the Philippines (hereinafter called "the Entity") of the one part and **ADA MANUFACTURING CORPORATION (ADAMCO)** of **Ropali Plaza, Josemaria Escriva Drive, Ortigas, Business Center, Pasig City, Metro Manila** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "**Supply, Delivery and Testing of 57 units Rice Combine Harvesters for Regions CAR & II, Lot 1**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Ninety Two Million Nine Hundred Ten Thousand Pesos and 00/100 only (Php 92,910,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Ninety Two Million Nine Hundred Ten Thousand Pesos and 00/100 only (Php 92,910,000.00)** or such other sums as may be ascertained, **ADA MANUFACTURING CORPORATION (ADAMCO)** agrees to **Supply, Deliver, Install and Test 57 units Rice Combine Harvesters for Regions CAR & II** in accordance with his/her/its Bid.




