**CONTRACT FOR SUPPLY, DELIVERY AND TESTING OF 50 UNITS RICE REAPERS FOR REGIONS CAR, X & BARMM, LOT 1 (PHILMECH-RCEF-23-06-11)**

THIS AGREEMENT made the 7<sup>th</sup> day of Sept 2023 between **PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHilMech)** of the Philippines (hereinafter called "the Entity") of the one part and **SUPER TRADE MACHINERY GLOBAL, INC.** of **937 EDSA, Philam, Quezon City, Metro Manila** (hereinafter called "the Supplier") of the other part;

  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Eight Million Six Hundred Thirty Nine Thousand Nine Hundred Fifty Pesos and 00/100 only (Php 8,639,950.00)** or such other sums as may be ascertained, **SUPER TRADE MACHINERY GLOBAL, INC.** agrees to **Supply, Deliver and Test 50 units Rice Reapers for Regions CAR, X & BARMM** in accordance with his/her/its Bid.



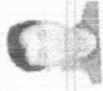

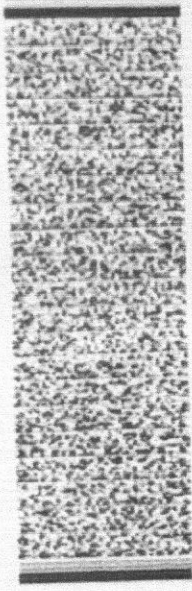
