CONTRACT FOR SUPPLY, DELIVERY AND TESTING OF 56 UNITS FOUR-WHEEL TRACTORS WITH ATTACHMENTS FOR REGIONS XI & XII LOT 6

(PHilMech-RCEF-23-09-21-Rebidding)
